Any donation of \$1,000 USD or greater recommended to a Tides Canada fund or project generates a U.S. charitable donation receipt. Americans or individuals with U.S.-sourced income can benefit from our international grant-making capability by making a donation to the Tides Canada Exchange Fund at Tides Foundation.

#### Here's how it works:

- Complete, print, and sign the form below. The charity information is pre-filled but you will need to specify the name of the fund or project you are donating to.
- Mail the signed form with your check payable to "Tides Foundation" in the U.S. to the following address: **Tides Foundation**, PO Box 29903, The Presidio, San Francisco, CA 94129-0903, USA
- Within three to six weeks of your donation, Tides Foundation provides you with an acknowledgment receipt that can be used for U.S. tax purposes.
- The Tides Canada fund or project receives the grant in four to six weeks in a Canadian dollar amount equivalent to your U.S. dollar gift minus the 2% retained by Tides Foundation.
- If you want to make a gift of securities to a Tides Canada fund or project please contact us for the securities donation form.
